DONATION & GRANT GIVING POLICY & APPLICATION FORM

The Parish Council wishes to support local groups/organisations who work within the parish/community to develop or enhance facilities available, or who contribute to the well-being of parishioners. Donation & grant giving is funded from annual precept income and forms part of the budget set annually in December.

Applicants must be non-profit making or charitable. Donation's & Grants will not be made retrospectively and only one application will be considered from an organisation in any one financial year. The financial year runs from 1 April.

Where possible, the Parish Council seeks to work with organisations/individuals to support their long term aims. A separate donation & grant application/review meeting will be required for each year.

When to Apply

All applications should be submitted by 1st November in time for the December Budget meeting. You will be notified of the outcome of your application after the December meeting. If successful, your donation & grant will be agreed by the Parish Council and then paid into the organisations bank account. (payment will be made by BACS only)

Eligibility Criteria

- Applicants must have a bank/building society account for their organisation with at least two signatories.
- Applicants must be non-profit making/charitable organisation operating within the parish of Wentworth. (Organisations may be registered as a charity, but non-registered organisations will still be eligible if a management committee is in place and all other criteria are met.)
- Applicants must have a constitution or equivalent to submit with their application. Terms of Reference, or Rules.
- Groups working together to run a project may be considered without a separate constitution but must have a separate bank account.
- The applicant's aims and objectives must be clear and show direct benefit to Wentworth parish/community and/or the lives of people within the Wentworth parish/community. The application must state how the Donation & Grant will aid their future plans.
- Full and complete copies of your signed, certified, and audited accounts for the last two years (if your organisation has been in existence for that period)
- Bank statements for the last 3 months, signed by a member of your organisation, indicating their position
- Detailed budget plan and supporting evidence.
- Evidence of any other awards towards the project e.g. lottery funding, other bodies.
- For grant requests for projects, evidence of tendering procedures followed (please refer to the Council's Donation/ Grant Policy for full details of what procedures are expected)

The Parish Council reserves the right to publish details of any Donation & Grant funding given and projects supported.

How to Apply for a Donation/Grant from the Parish Council?

Applicants are required to supply: -

A completed application form available from the Clerk or it may be downloaded from the Parish Councils website.

The application form should be accompanied by the documentation requested below: -

- where appropriate, audited accounts or accounts that have been independently examined by a suitably
 qualified person, for the previous financial year (or in the case of a newly formed organisation, a
 comprehensive budget and business plan, also an organisational structure and bank account details);
- Bank statements for the last 3 months, signed by a member of your organisation, indicating their position.
- a statement in support of your request (including photographs and plans if applicable);
- where appropriate, a copy of your organisation's constitution.

If the applicant is an organisation, the organisation should usually have a bank account in its own name.

The Parish Council reserves the right to request any additional information to aid determination of the donation or grant.

All applicants completing an application form will be deemed to have read and agreed to the requirements outlined in this Policy.

All sections of this application form must be completed and returned with the necessary documentation

The Parish Council's Donation/Grant Awarding Policy cannot be used to support

- costs of routine maintenance and repair of equipment (unless in exceptional circumstances).
- salary or routine administration costs
- individuals
- hospitality.

Applicants for Donations/ Grants from the Parish Council should be aware: -

- if the project is relying on funding from the Parish Council, it should not be started until the award of a Donation or grant has been confirmed in writing by the Clerk.
- If a project has already started, it cannot be funded through this scheme;
- Donation or grant will not be awarded retrospectively.
- Donation or grant may be for less than the amount requested.
- If the group is unable to use the donation or grants for the stated purposes and within the stated timescale, monies must be returned to the Parish Council.
- The Donation or grant must be used only for the purpose for which the application was made.

To support the donation or grant the Parish Council will ask for an end of project report.

If the Parish Council determines that the monies have not been used properly or a report is not provided then the Parish Council may require the funds to be returned.

Awards for funding which are not for projects within the current financial year will be considered on a case by case basis.

Terms and Conditions

By applying you confirm you are an official representative of your group and are authorised to apply for funding on their behalf.

Your details can be held with Wentworth Parish Council in accordance with the Data Protection Act to administer the donation or grants process.

The information provided in this application is a fair and accurate description of your group and the project for which you are seeking funding.

Misleading of inaccurate information may result in your application being rejected. Late applications or failure to complete any section of the application form may result in your application being delayed or rejected.

Information about your group and your project may be made available as part of Wentworth Parish Councils decision making process. Personal contact details and bank details will not be made public.

You will provide Wentworth Parish Council with any information they request to enable them to assess your application.

This may include (but is not restricted to) a copy of your constitution, accounts or bank statements, equal opportunities policy, insurance and relevant health and safety policies.

You will provide Wentworth Parish Council with any evidence or monitoring information they request to ensure that any donation or grants awarded has been spent in accordance with this application and any other terms and conditions.

Donation or grants funding may be subject to additional terms and conditions, which will be made available to you if your application is successful.

The Parish Council's decision will be final.

Submission of this application does not automatically mean that an award will be Granted. Wentworth Parish Council reserves the right to award Donation/Grants at their discretion. Only one project per application will be considered.
